



- 4. Follow up on recommendations and take corrective actions.


The role of the Public Safety Department is not limited to monitoring and identifying risks, but




Health Section

Key performance Indicator (KPI)

To effectively monitor and measure a company's performance, there should be a mix of leading and lagging indicators. Most companies can easily define the desired results (lagging indicators) they wish to achieve, but often struggle to define leading indicators. Here we define a leading indicator and give examples of some good ones.

The benefits of training on an ongoing basis also includes the maintenance of team cohesion, the creation of a common mindset and a shared vocabulary. As with learning, in general, there are, however, several clear benefits.

As is the case with the Jordan Industrial Ports Company, there is internal and external training that employees receive to increase their practical performance, as this is done through the training plan for each department.





- Signs/ Brochure

Safety Signs are crucial in any work environment. The primary importance of displaying Safety Signs is to prevent injury and ensure staff and visitors are aware of the possible dangers and hazards ahead in certain situations and/or environments. Without signs, many employees would lack the necessary direction in times of crisis, and employers might find themselves in significant legal difficulties if any accidents were to arise as a result.

- Safety Walk

A safety walk-around is when a line manager or supervisor observes work taking place, inspects the workplace, and discusses safety performance with staff based on their observations.

Safety walk is through the accredited committee, where the committee consists of the safety manager and the dock manager, and employees from all departments (Safety, Technical and Operations Department) participate.





- Risk assessment

Establishing a risk assessment aims to reduce existing risks and develop prevention standards to reduce any potential risks, thus ensuring the safety of the occupational environment.

- Safety talk

This is a kind of indicator where an effective and continuous safety talk is conducted in which safety issues are addressed with employees and safety management to ensure that the operational process proceeds in a safe and sound manner away from risks.






- Safety Tour

These tours aim to inspect the site and workplace and ensure the environment is safe and risk-free.



- Near miss Report

This report aims to monitor, verify, and address all unsafe situations.





- Employee Participation

Employee participation is the process whereby employees are involved in decision making processes, rather than simply acting on orders. Employee participation is part of a process of empowerment in the workplace.
